- * **PLAN "A"** **FULL PAYMENT--with 5% discount--by July 1.**

- * **PLAN "B"** **TWO PAYMENTS--with discount 3%--by Sept. 1 and January 1.**
Sept. 1=\$3880.00 + \$350.00=\$4230.00; Jan. 1=\$3880.00.

- * **PLAN "C"** **TEN INSTALLMENTS** including \$100.00 surcharge. First installment of \$810 for returning students by July 1st, for new students upon entry. Nine installments of \$810 follow on or by the 1st day of each month.

PLEASE NOTE CAREFULLY

1. \$350.00 non-refundable REGISTRATION/STUDENT FEE due the day a student enrolls.
2. \$50.00 per month LATE FEE charged to delinquent accounts on 1st day of month due; 10% per year LATE FEE to year-end delinquent accounts. Non-collected year-end accounts submitted to the Credit Bureau of St. Croix. NO CHECKS accepted for delinquent accounts.
3. \$35.00 SERVICE FEE charged on ALL returned checks. After one returned check, only cash, a certified check or money order accepted for payments.
4. Enrollment is for the full school year; the full year's Tuition is due, even if a student is withdrawn, expelled, removed for tuition indebtedness, or entered at a date other than mutually agreed by home and school.
5. For students entering during the school year, Tuition Fees are prorated on the ten installment payment basis, plus one month, and Registration/Student Fee; first payment due upon entry.
6. ALL returning student accounts must be paid in full prior to payments made for the next year.
7. Accounts must be current for release of any and all records, and uninterrupted attendance.
8. Family enrollment of three or more may qualify for a discount of \$500 per child per school year.
9. Children of Manor graduates are eligible for a \$1000 scholarship on personally paid accounts.
10. Parents may apply for scholarships and financial aid; recipients must monitor their children's obligations, and help with ALL fundraisers. (Kindergartners are not eligible for all scholarships.)
